## **Giving**

### Why should I give?

“You know the grace of our Lord Jesus Christ, that though he was rich, yet for your sake he became poor, so that you through his poverty might become rich” (2 Corinthians 8:9). Christians want to give so that more people can hear this good news of forgiveness and eternal life. Giving is part of our worship of God, and it helps us love him rather than money. No one at St Mary’s (including the minister) will know how much you give except one or two people who help with finance admin. Why not read 2 Cor 8 & 9 and pray about your giving? “Each of you should give what you have decided in your heart to give, not reluctantly or under compulsion, for God loves a cheerful giver” (2 Cor 9:7).

### How is my money used?

*Church workers* – at the moment we receive an enormous amount of help from the Church of England to fund our church staff. They equip the whole church family to grow and serve others, by teaching the Bible and praying. Our prayer is that over time we will be able to cover more and more of these costs ourselves, as we ought to – see 1 Timothy 5:17-18.

*Mission partners* – every year we send 10% of our giving to gospel ministry elsewhere, so others can hear about Jesus.

*Running costs* – e.g. heating, lighting and publicity, plus we contribute towards the practical help we receive from the Church of England.

### How can I give?

*Monthly bank donations* – these make life easy for volunteers who help with finance admin, and help the church predict its income. Use the banker’s order, or give online (St Mary’s PCC, sort code 05-04-16, account 52674173).

*Numbered envelopes* – you can give anonymously. Please ask the treasurer.

*Cash or cheques (payable to “St Mary’s Wheatley PCC”)* – put in a giving plate any Sunday, and children can put in coins.

### What is Gift Aid?

If you pay tax St Mary’s can receive an extra 25p for every £1 you give, at no extra cost to you. Please read and sign the Gift Aid declaration, and make sure all your gifts have your name on them (cheque, banker’s order, online) – or that you use a numbered envelope. There are also small one-off Gift Aid envelopes in the pews for visiting Christians.
